## Compliance status

Current status: Partially compliant.

This website is partially compliant with the requirements of Appendix A of UNI CEI EN 301549 standard due to the cases of non-compliance listed below.

## Content not accessible

### 1.1.1 Non-text content

Some non-text content presented to the user does not have a text alternative that serves the equivalent purpose.

### 1.3.1 Information and correlations

In some cases, information and correlations among elements (headings order, forms labels, list elements), are not provided programmatically.

### 1.4.3 Minimum contrast ratio

The visual representation of text and images of text does not always have the required minimum contrast ratio.

### 1.4.4 Resizing of the text

Text cannot be resized up to 200% without the aid of assistive technologies and without loss of content and functionality.

### 1.4.10 Recalculation of the flow

Content cannot always be resubmitted without loss of information or functionality and without requiring scrolling in two dimensions.

### 2.1.1 Keyboard

Not all content features are usable via a keyboard interface.

### 2.4.3 Focus order

Web pages cannot always be browsed sequentially.

### 2.4.6 Headings and labels

Headings and labels are not always used to describe topics or purposes.

### 3.3.1 Identification of errors

When an insertion error is detected, the error is not always identified and described by text.

### 3.3.2 Labels or Instructions

Labels or instructions are not always provided when content requires user input actions.

### 4.1.2 Name, role, value

Not all user interface components are programmatically determined.

### 4.1.3 Status messages

Notification of the state change of some elements does not occur in a programmatic way.
